Details of Your Order

No changes or alterations to the original order can be accepted after 3 working days from the order date.

Payment

On placing your order payment of 50% is required. Orders under €500.00 must be paid in full at time of placing the order. Balance is payable 3 days before delivery, with the exception of cheque payments which must be paid 5 working days before delivery. Goods can only be collected once paid in full.

Orders may be cancelled within 3 days from the order date, and all monies paid will be refunded less an administration fee of \leq 40.00. Cancellations after this time will be subject to a 40% charge.

Delivery Time

We will process your order as quickly and efficiently as possible. The majority of our furniture is sourced from suppliers in Denmark and is prepared for each order individually.

The estimated delivery date given to you is approximate and is given in good faith. If it is delayed we will endeavour to inform you as soon as possible, however, we cannot accept any liability for consequential losses as a result.

Home Delivery & Assembly
